We request you to register using our Customer portal / Mobile App to avail this facility.

FOR UNREGISTERED DEPOSITORS

Registration procedure to access our Customer portal:

- 1) Please visit our website <https://portal.sfl.in/sfportal/faces/sflogin.jsf?templd=1>
Mobile App - SF CUSTOMER PORTAL in Android Play Store
- 2) Select login --- Click SF Customer
- 3) When our portal opens, click NEW USER
- 4) Type out your Customer id :
- 5) Enter your Date of Birth
- 6) Enter your mobile number
- 7) Tick the **declaration** before submission
- 8) Select a security question of your choice and answer the same
- 9) An OTP will be sent through SMS to your registered mobile number (E.g.: **9876543210**) to change the password as per your preference.
- 10) Again login by entering either your Customer id or Mobile number
- 11) Click **Transact** to submit Form 15G/H or **Account summary** for viewing deposit details

Upon login, click the “Transact” tab and choose Renewals / Additional deposits to proceed further.

Renewals

Individual depositors can renew their existing deposits as either a Fixed Deposit or Cumulative Deposit.

Sundaram Finance Limited

For Cumulative Deposits you can opt to renew the entire maturity value or renew the principal and opt for the balance amount to be credited to your registered Bank account.

You may also opt to convert your existing Cumulative Deposit to a Fixed Deposit. If this is preferred the Deposit must be renewed in multiples of 1000/- only.

In case of Deposits placed on an A or S (Anyone or Survivor) basis, the matured TDR must be duly signed by all Depositors and thereafter scanned and uploaded using the “browse” option in the same screen.

Additional Deposits:

Individual Depositors can place an additional Deposit to their existing Deposit account(s).

The order of names, Bank details and Nominee details of the existing Deposit must be the same when placing an additional Deposit.

There are two options for placing additional Deposits Online:

- 1) The Depositor can login into our Portal and seamlessly transfer funds using the Billdesk / Techprocess payment gateway
- 2) Funds can be transferred to the designated bank account of SFL and transfer details can be provided. In case you wish to transfer funds externally and make additional deposits, kindly use the following bank details:
