 comprehensive income as per IND AS 109 from the quarter ended March 2024, Accordingly, the total comprehensive income for the quarter ended June 2024 is not comparable with that of the corresponding previous
 year periods.
- The figures for the quarter ended 31st March, 2024 are the balancing figures between audited figures in respect of the previous full financial year and the published year to date figures upto the end of third quarter, which
 were subjected to limited review,

- 6. The Joint Statutory Auditors have carried out a Limited Review of the financial results for the quarter ended 30th June 2024.
